The University's academic year was divided into four quarters: Fall, Winter, Spring and Summer. Fall 2000, Auburn University converted to the semester system. Prior terms are on a quarter system; however, the transcript reflects the quarter to semester conversion. One hour under the quarter system is equivalent to 0.67 hours under the semester system.

GRADE ADJUSTMENT POLICY (GAP) - Effective Fall 2000, all currently enrolled, regularly admitted undergraduate students may delete a maximum of three (3) course grades of D or F (including FA or U) associated with their undergraduate degree program from the computation of their cumulative GPA. Grades or credits considered as transfer credits, courses earned in a previously awarded baccalaureate degree, or grades that have been assigned as a result of academic misconduct are excluded from this policy. This policy does not offer exemption from academic requirements for Auburn University degrees. Adjustment only applies to grades in individual courses. All courses for which a grade is awarded at Auburn University will remain on the transcript. Deletion of grades is only available to currently enrolled, regularly admitted undergraduate students and is not available to former students.

Graduate level courses that bear the prefix of X in the grade are courses which have been taken out of the calculation of hours and grade point averages due to academic bankruptcy.
